**Set-Up**

*MDGLCC Explore / EXPO: Saturday, October 23, 2010*

Further set-up instructions will be provided upon registration. Booth configuration: flame-proof drapes 8' high back and 3' high side to be set up in a 10' x 10' area. Each booth to include a one-line 7" x 44" identification sign, one 500 watt 120 volt electrical outlet, one 6' x 24" skirted table, two chairs, one wastebasket.

*MBGP: Saturday, April 16, 2010*


Further set-up instructions will be provided upon registration. No cars will be allowed in festival area. You must communicate your needs for trucking assistance on the "Vendor Information Sheet" which will be provided by MBGP upon confirmed booth reservation.

*\*(includes a \$100 discount off MBGP standard booth price; a 50% deposit of MBGP booth price must be paid by 10/22/10, balance due by 1/31/11 else full pricing of \$450 per booth will apply)*

*\*\* (includes a \$25 discount off MBGP standard booth price; a 30% deposit of MBGP booth price must be paid by 10/22/10, balance due by 1/31/11 else full pricing of \$175 per booth will apply)*

## Special Notes:

- 1) By submitting this "Booth Application," you hereafter are referred to as "Vendor."
- 2) All booths are covered spaces. MDGLCC Explore / EXPO is indoors, MBGP's are under tents. Vendors may not erect their own tents or coverings in designated area without prior approval.
- 3) Booth fees are non-refundable.
- 4) No food or beverage may be sold or distributed without approval and associated fees and insurance requirements may apply. Sample sizes of products may be distributed but only with prior approval.
- 5) All booths must be open to the public by 12 noon on day of event and must remain open until the closing of the Vendor area. (MDGLCC Explore / EXPO = 5PM, MBGP = 6PM)
- 6) The sharing of booths must be pre-approved by event organizers. Non-profits sharing space with for-profits are not eligible for the non-profit rate.
- 7) All business or other activity for which Vendor has rented space for must be conducted in the designated booth area ONLY. Distribution, layout or hanging of any items outside designated booth area is NOT PERMITTED.
- 8) All materials deemed offensive by MDGLCC or MBGP, in their sole discretion, will not be permitted to be sold or displayed.
- 9) The Vendor and its employees are expected to monitor themselves on all matters of conduct, attire, etc.
- 10) No display over 8 foot in height or extending beyond the designated area is permitted without prior approval from organizers.
- 11) It is the Vendor's responsibility to pay any and all applicable state and local taxes. MDGLCC and MBGP assumes no responsibility whatsoever for collecting or emitting taxes and/or fees of any kind that may be due from any exhibitor.
- 12) Each vendor is required to be properly insured. MDGLCC and MBGP require a certificate of insurance or other evidence of insurance to be submitted prior to event.
- 13) The Vendor shall not display, offer for review or sell any illegal or contraband items. The Vendor shall comply with all applicable laws, regulations and ordinances of the State of Florida, County of Miami-Dade and City of Miami Beach.
- 14) The Vendor shall not display, offer for review or sell any items that are unlicensed and/or copies/interpretations of licensed or registered items at or in connection with either event.
- 15) The Vendor understands that MDGLCC and MBGP have no control over weather, acts of God, acts of terrorism, or Government intervention or any other cause that may impair, prevent, end or interrupt the events.
- 16) MDGLCC & MBGP will provide security during set-up and on day of the event ; however, MDGLCC, MBGP and the City of Miami Beach shall not be responsible for any items & the Vendor is solely responsible for the security of all items in their booths at all times.
- 17) The Vendor hereby agrees to indemnify and hold MDGLCC and MBGP harmless for any and all claims and losses arising out of, or relating to a breach of this agreement or a failure of a Vendor that should arise because of such event.
