Further set-up instructions will be provided upon registration. Booth configuration: flame-proof drapes 8' high back and 3' high side to be set up in a 7' x 9' area. Each booth to include a one-line 7" x 44" identification sign, one 6' x 24" skirted table, two chairs, one wastebasket.

Special Notes:

- 1) By submitting this "Booth Application," you hereafter are referred to as "Vendor."
- 2) All booths are covered spaces. MDGLCC Explore / EXPO is indoors and in air conditioned space. Vendors may not erect their own tents or coverings in designated area without prior approval.
- 3) Booth fees are non-refundable.
- 4) No food or beverage may be sold or distributed without approval and associated fees and insurance requirements may apply. Sample sizes of products may be distributed but only with prior approval.
- 5) All booths must be open to the public by 12 noon on day of event and must remain open until the closing 5pm of the Vendor area.
- 6) The sharing of booths must be pre-approved by event organizers. Non-profits sharing space with for-profits are not eligible for the non-profit rate.
- 7) All materials deemed offensive by MDGLCC, in their sole discretion, will not be permitted to be sold or displayed.
- 8) The Vendor and its employees are expected to monitor themselves on all matters of conduct, attire, etc.
- 9) No display over 8 foot in height or extending beyond the designated area is permitted without prior approval from organizers.
- 10) It is the Vendor's responsibility to pay any and all applicable state and local taxes. MDGLCC assumes no responsibility whatsoever for collecting or emitting taxes and/or fees of any kind that may be due from any exhibitor.
- 11) The Vendor shall not display, offer for review or sell any illegal or contraband items. The Vendor shall comply with all applicable laws, regulations and ordinances of the State of Florida, County of Miami-Dade.
- 12) The Vendor shall not display, offer for review or sell any items that are unlicensed and/or copies/interpretations of licensed or registered items at or in connection with either event.
